

Privacy Policy

This Privacy Policy was last updated on February 9, 2026.

Welcome! You have arrived at an online service location (e.g. website or mobile application) (collectively referred to herein as a “Service”) that is owned and operated by StatDebrief, Inc. (“StatDebrief”). This Privacy Policy applies to users of a Service, and describes:

- Information that we receive from you when you interact with the Website and App
- How we use and process the information that we receive
- If and why Personal Information may be disclosed to third parties
- Your choices regarding the collection and processing of your Personal Information

This Privacy Policy applies to your use of interactive features, widgets, plug-ins, applications, content, downloads and other services that StatDebrief owns and controls and makes available through an online service or where StatDebrief posts a link to this Privacy Policy, regardless of how you access or use the Service, whether via personal computers, mobile devices or electronic media. This Privacy Policy applies to information we collect online through a Service and in connection with related communications (including email) that reference this Privacy Policy. It does not apply to information collected entirely offline or by third-party websites, platforms, or services that we do not control (“Third-Party Services”).

The amended Privacy Policy supersedes all previous versions.

Information we collect about you

We receive and collect information that you directly submit to us or that we gather when you use a Service, including personal information such as your name, mailing address, telephone number, email address, hospital or organization, job function, and payment information, as well as non-personal information such as IP addresses, information that is passively or automatically collected through cookies, your browser or device, or other services, and information from third parties. We may also collect information on your physical location, which may be provided by you or collected through the use of our Website, App, or other communication channels. In this Privacy Policy, we refer to all of the above as “Personal Information.”

Cookies

A cookie is a small piece of data sent from a website and stored on your computer by your web browser. Cookies contain information about your computer, such as a user ID, user settings, browsing history and activities conducted while using the Services. Cookies are not themselves personally identifiable but may be linked to Personal Information. A cookie typically contains the name of the domain (internet location) from which the cookie originated, the “lifetime” of the cookie (i.e., when it expires) and a randomly generated unique number or similar identifier. The file is added once you agree to store cookies on your computer or device, and the cookie helps analyze web traffic or lets you know when you visit a particular site. Cookies allow sites to respond to you as an individual. The Website and App can also tailor its operations to your needs, likes, and dislikes by gathering and remembering information about your preferences. We use other cookies and other data collection tools (such as web beacons and server logs), which we collectively refer to as “data collection tools,” to help improve your experience with the Website and App. For example, data collection tools help us remember users and make the Website or App content or interface more relevant to them.

Specifically, the Service may use cookies to:

- Analyze Service traffic using an analytics package;
- Identify if you are signed in to the Service;
- Test content on the Service;
- Store information about your preferences; or
- Recognize when you return to the Service.

Overall, cookies help us provide you with a better experience, by enabling us to monitor which pages you find useful and which you do not. You can accept or decline cookies. - manage payment processing and other transactions;

- send you information about changes to our terms, conditions, and policies; carry out our obligations and enforce our rights arising from any contracts entered into between users and us, including for collection of payments; provide you with email alerts, event registrations, promotions, and other notices concerning our products or services, or events or news, that may be of interest to you;

- to any company we might merge with or acquire, or that acquires us, or in the event of structural change of our company of any form (e.g., a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding).

We may also disclose, without restriction, aggregated information about our users and information that does not identify any individual user. Our continued use of aggregated and de-identified data will comport with applicable law.
